## MEETING MINUTES on JANUARY 21, 2121

Ellie wanted to know if the summer group wanted her to plan for luncheons for the summer; the summer group agreed to have the luncheons Ellie will set these up and the first luncheon will be in April.

Marcia Zenk completed the booklets and gave them to all the Captains so they can distribute to their team players.

Nancy Bellavance asked for three volunteers to be on the nominating committee to find new officers. Marion Lloyd, Marianne Todd, and Ellie Johnson volunteered to be on the committee.
